**MULTIPLE CHOICE QUESTIONS (Time: 40 minutes)**

1. FREE-QUESTION. The capital of Spain is:

- (A) Paris      (B) Sebastopol      (C) Madrid      (D) Londres      (E) Pekin

**Questions 2 to 5 refer to the following exercise:**

Let  $X$  be a random variable with probability density function given by:

$$f(x, \theta) = \begin{cases} \frac{1}{24\theta^5} x^4 e^{-x/\theta} & \text{for } x \geq 0, \theta > 0; \\ 0 & \text{otherwise} \end{cases}$$

In addition, it is known that the mean of  $X$  is  $m = 5\theta$  and that its variance is  $\sigma^2 = 5\theta^2$ .

We wish to estimate the parameter  $\theta$  so that, in order to do so, a random sample of size  $n$ ,  $X_1, X_2, \dots, X_n$ , is taken.

2. The method of moments estimator of  $\theta$ ,  $\hat{\theta}_{MM}$ , will be:

**Questions 6 and 7 refer to the following exercise:**

Let  $X$  be a discrete random variable with probability mass function given by:

$$P(X = 0) = 2\theta, \quad P(X = 1) = 3\theta, \quad P(X = 2) = 1 - 5\theta$$

In order to estimate the parameter  $\theta$ , a random sample has been taken, providing the following results: 0, 0, 1, 2.

6. The method of moments estimate of  $\theta$  is:

- (A)  $\frac{15}{28}$       (B)  $\frac{9}{20}$       (C)  $\frac{17}{20}$       (D)  $\frac{5}{28}$       (E)  $\frac{3}{20}$

**Questions 8 to 10 refer to the following exercise:**

Let  $X$  be a random variable with probability mass function given by:

$$P(x, \theta) = \frac{1}{x!} e^{-\theta} \theta^x, \quad x = 0, 1, 2, \dots, \quad \theta > 0$$

We wish to test the null hypothesis  $H_0 : \theta = 1$  against the alternative hypothesis  $H_1 : \theta = 2$ . In order to do this, a random sample of size  $n = 1$ ,  $X_1$ , has been taken.

8. The most powerful critical region for this test is of the form:

- (A)  $[C, \infty)$       (B)  $[C_1, C_2]^C$       (C) All false      (D)  $[C_1, C_2]$       (E)  $[0, C]$

9. If we decide to reject the null hypothesis if  $X_1 \geq 3$ , then the significance level for this test is, approximately:
